Applications are invited from the eligible candidates for appointment to the post of Tractor Mechanic-cum Driver, a General Central Service Group 'C' Non-Gazetted, Non Ministerial post in the Level-4, Cell-1 (Rs. 25500-81100) as per 7<sup>th</sup> CPC at National Sugar Institute, Ministry of Consumer Affairs, Food & Public Distribution, Department of Food & Public Distribution, Kanpur. The post of Tractor Mechanic-cum-Drive is to be filled up on deputation from amongst candidate under Central or State Governments or Union territories or Public Sector Undertakings or Semi-Government or Autonomous or Statutory Organizations under fulfilling the following:-

#### **Deputation:**

1. Officials of the Central or State governments or Union territories or public Sector Undertakings or Semi-Government or Autonomous or Statutory Organizations:-
  - (a) (i) holding analogous posts on regular basis: or
  - (ii) with five years' regular service rendered after appointment thereto in level-3 in the pay matrix: or
  - (iii) with eight years' regular service rendered after appointment thereto in level-2 in the pay matrix: and
- (b) Possessing the following educational qualifications and experience
  1. 12<sup>th</sup> standard pass with Tractor Mechanic Trade certificate from Industrial Training Institute or Government Institute.
  2. At least two years experience in overhauling and general maintenance of Tractor and vehicles, both Diesel and petrol driven.
  3. Ability to take up independent charge of repair, overhaul or heavy tractors, trucks and Motor vehicles.
  4. Should possess proper license for driving Tractors and Motor vehicles.
2. The Departmental Tractor Driver with eight years regular service in the grade will also be considered along with deputationists. In case, he is selected for appointment, the post shall be deemed to have been filled by promotion.

**Note 1 :-** The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by promotion.

**Note 2 :-** Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years. The maximum age-limit for

appointment by transfer on deputation shall not be exceeding fifty-six years as on the closing date of the receipt of applications.

The place of posting will be National Sugar Institute, Kanpur (Uttar Pradesh) but liable to be posted anywhere in India.

Candidates who once apply for the post will not be allowed to withdraw their candidature later subsequently.
