G.S.R. 3—In exercise of the powers conferred by the proviso to article 309 of the Constitution the President hereby makes the following rules further to amend the National Sugar Institutes, Kanpur (Group 'A' and Group 'B' Posts) Recruitment Rules, 1964, namely:—

1. (1) These rules may be called the National Sugar Institute, Kanpur (Group 'A' and Group 'B' Posts) Recruitment (Second Amendment) Rules, 1988
- (2) They shall come into force on the date of their publication in the Official Gazette.

2. In the schedule to the National Sugar Institute, Kanpur (Group 'A' and Group 'B' Posts) Recruitment Rules, 1964 after serial number 55 relating to Hindi Officer and duties relating thereto, the following serial number and duties shall be added namely:—
