I would like to inform that I am serving as **Junior Scientific Officer (Physical Chemistry)** in the Institute since **05/09/2014** and prior to joining this Institute, I had applied for the post of Chemist in Geological Survey of India Ministry of Mines, Govt. of India (GSI) (UPSC Advt. No. 5/2014 GEOL).
