seen from the copy of the interview call letter (issued without any reference or file number & date) enclosed with the above letter has not been issued from this Institute.

Neither the Institute is having any post of Lab Research Analysis wing and Structured Data Provider (as mentioned in the enclosure to the RTI application of the probable interview call letter which reads "Recruitment to the post of Lab Research Analysis wing and Structured Data Provider in UP Zone Sugar Institute 2014 Examination") nor has any such position of Regional Director who had purportedly signed the Interview call letter for the so-called examination named "UP Zone Sugar Institute 2014 Examination" as per enclosed annexure to RTI application.

Further, the letter head of the said interview call letter is that of Department of Food & Public Distribution (Ministry of Consumer Affairs, Food & Public Distribution, Krishi Bhavan, New Delhi Govt. of India) and designation of signatory to the said letter is Regional Director. The name of Regional Director is also not mentioned and his/her signature is also unreadable/appears to be manipulated.

It is also informed that no examination named "UP Zone Sugar Institute 2014 Examination" has been ever conducted at or by this Institute.

However, considering that having issued on the letterhead or possible misuse of name of the Department of Food and Public Distribution, the application is transferred back under section 11 read with section 5 (4) of the RTI Act, 2005 to the possible CPIOs of the Department to which the matter may be related.
