

Sir,

With reference to your letter dated 17.12.2014, received in this office on 23.1.2015, it is to inform you that -

1. Under the RTI Act, 2005, the Public Information Officer is required to supply the material in the form as held by the Public Authority, but not to do research on behalf of the citizen to deduce anything from the material and then supply the same to an applicant. The information is required to be provided in the form as it exists. The PIO is also not required to furnish information which requires drawing of inference and/or making assumption or to interpret information or to solve the problems raised by the applicant or to furnish replies to hypothetical questions.

In view of the same, it is concluded that the information sought by you like why the Ministry delayed the matter? Who will suffer the loss of delay? Why the Ministry never informed Shri Sushil Kumar Tiwari about it, does not exist in the records.

Under these circumstances it is not possible to reply to hypothetical questions by drawing inferences.

2. (a) No appointment has been made on compassionate ground after 01<sup>st</sup> January 2003.

(b) The appointment on compassionate grounds are made subject to instruction laid down on the subject and limited by the percentage ceiling prescribed; it was informed you vide letter of even number dated 11.12.2014 that 5% quota of compassionate appointment is already completed.


