Myself Garima Gupta had asked for the information under RTI through letter dated 9/9/14 and you had replied partially to it vide your letter dt. 10.10.14. I am sorry to say that the reply given by you is INCOMPLETE. I fail to understand that intentionally you had given incomplete information or you had taken the letter very casually and replied accordingly with casual approach. In my letter, kindly refer point 3 and point 4 which states :-

3. Kindly provide me the names and the durations since when they are serving in your institute.
4. What are the total money they had drawn till now (month wise) since Jan 2013.

I had asked you the information since Jan 2013 but you had only given information since July 2014 and you were totally silent from Jan 2013 to June 2014. Kindly provide the details of it also. Secondly, I had asked you that what was the total money drawn by them since Jan 2013, but instead of it you had given me the rate at which the payment is made to them. This does not tell that what is the total money drawn by them on monthly basis.

Kindly provide me the full and complete information with the evidence (i.e. photocopies of their receipts.) monthwise since Jan.2013. You will agree that I had given extra postal order to meet your photocopy charges.
