With due respect, I want following Information in reference to vacancy No. 14020302422 published vide Advt. No. 03/2014 in Employment News dt 22-28 Feb.2014 by Union Public Service Commission for recruitment of Senior Administrative Officer in National Sugar Institute, Kanpur:-

- I) What is the meaning of term(s) "working in a supervisory capacity" and "supervisory Post"? Please send me certified copy of Government Circular/Notification regarding this.
- II) Whether definition, as given under the vacancy No. 14020302422 vide Advt. No. 03/2014, of the term "supervisory capacity" as posts in PB-2 Rs.9300-34,800/- with grade pay of Rs.4600/- is applicable to this post only or for all other future vacancies until there is some amendment in the existing rule?
- III) I am working as an "Assistant" in an Autonomous Organisation under the State Govt. with grade pay of Rs. 4600/- in PB-2(old pay scale of 6500-200-10500) since my joining. Whether my post comes under the definition of "Supervisory Capacity/Post" or not?
- IV) What is the difference between the terms "Supervisory Capacity" and "Supervisory Post" ?
- V) Is it possible that some one is working in a "Supervisory Capacity" but his/her post is not "Supervisory" in nature?
- VI) Whether all the posts carrying GP of Rs. 4600/- in PB-2 comes under the category of working in a "Supervisory Capacity" or there is some specification of posts which come under that category?


